Featured Speakers



ANNESHIA FREEMAN

Anneshia Freeman is the creator and director of a copyrighted, trademarked, cognitive restructuring and resocialization program entitled The Lies That Bind – The Legacy of the Locks® also known as The Lies That Bind®. The program is based on the work of several experts in the fields of neuroscience and psychology as well as the results of a 15-year participant/observation, exploratory, ethnographic research project of several inner-city subcultures.

Anneshia was employed at Arbor Circle Corporation from 2005 to 2012 where she trained nine MSW therapists in her program methodology. The methodology was piloted within the Mission Inn program for five years. The Mission Inn program assisted women with children under the age of five in stopping the generational cycles of drug addiction and poverty in their families. Anneshia Freeman provided cognitive restructuring and resocialization program services for Drug Court and Sobriety Court clients from December 2003 – February of 2015. The Lies That Bind® continued being utilized by 61st District Court programs, facilitated by a counselor trained and certified to use the model, until he retired in August of 2020. Anneshia developed an adolescent version of The Lies That Bind® Program that has been utilized by Central City Weed and Seed Program, The Hispanic Center, Urban Family Ministries, Kent County Juvenile Detention Center, Arbor Circle's Homeless Youth Program, Habitat's YouthBuild Program, Youth Opportunity Program in Toledo, Ohio, and Michigan Youth Challenge Academy. Anneshia Freeman is a highly rated motivational speaker and trainer for various sectors of the human service industry. Anneshia Freeman is a published author and in 2012 established her own consulting firm known as, "Anneshia Freeman and Associates Consulting Services, LLC."



JULIA DALE

Julia Dale has more than 20 years of service to the residents of the state of Michigan in leadership and management roles throughout government. Dale was appointed as director of the Unemployment Insurance Agency, where she directs a staff of approximately 700 that is committed to excellence in serving the

residents of Michigan. Dale's extensive career, education and training give her the tools to focus on helping all Michiganders and provide exceptional customer service to residents and businesses.

Dale was serving as the director at the Department of Technology, Management and Budget when she was appointed by Gov. Gretchen Whitmer to lead the UIA. Dale, who holds a law degree from Wayne State University and is a graduate of James Madison College at Michigan State University, previously worked as an Assistant Attorney General and Section Head of the Department of Attorney General's Business and Charities Section.

Prior to her role with the Attorney General, Dale served as Policy Specialist, Division Director, Deputy Bureau Director and Bureau Director of the Corporations, Securities and Commercial Licensing Bureau Director at the Department of Licensing and Regulatory Affairs. While at LARA, Dale also served as Securities Administrator and Cemetery Commissioner. She started her public service career as a Civil Rights Representative and Manager for the Michigan Department of Civil Rights.



SUSAN CORBIN

Susan Corbin, director of the Michigan Department of Labor and Economic Opportunity, has been with the department since its creation in August 2019.

In the past, Susan has served as a Senior Advisor in the Office of Governor Whitmer, Director of

Customer Assistance in the Michigan Public Service Commission, Deputy Director and Chief of Staff for the Department of Energy, Labor & Economic Growth where she had oversight responsibility for the Unemployment Insurance Agency, the Worker's Compensation Agency, and the Michigan Occupational Safety and Health Administration. She has also served as Director of Appointments for Governor Granholm.

Ms. Corbin began her professional career working for the Michigan Departments of Commerce, Labor and Transportation assisting with their cultural, educational and trade relations with the People's Republic of China.

She has a degree in International Relations from James Madison College at Michigan State University.



ELIZABETH HERTEL

Elizabeth Hertel is the director of the Michigan Department of Health and Human Services. Previously, she was Senior Chief Deputy Director for Administration, where she oversaw External Relations and Communications, Financial Operations, Legislative Services, Legal Affairs, Policy & Planning, Strategic Integration, Organizational Services, Workforce Engagement and

Community and Faith Engagement.

Hertel joined the Michigan Department of Community Health (MDCH) in 2013 as the senior assistant for Policy and Planning, and in February 2014, was appointed director of Policy and Planning. Following the merger of the Departments of Community Health and Human Services into MDHHS in 2015, Hertel served as senior deputy director for Policy, Planning and Legislative Services. In October 2016, she left that position to serve as director of Michigan Advocacy for Trinity Health and returned to MDHHS as the Chief Deputy of Administration in February 2019.

Prior to joining MDCH, Hertel worked as a senior advisor for Health Policy in the state House Republican Policy Office and as a legislative assistant to state Rep. Bruce Caswell. She began her tenure in the House in 2005. In 2010, she worked as a consultant with Public Sector Consultants and then as a policy analyst at Blue Cross Blue Shield. She returned to the House in 2011.

She earned a bachelor's degree at Grand Valley State University and an MBA at Michigan State University.

Opportunities to Engage with Medicaid Payers to Expand CAA Community Resource Portfolios

In the Fall of 2023, the MDHHS released an RFP that would renew Michigan Medicaid health plan contracts for the next five years with three one year extensions. CAAs are in a unique position to meet these new requirements on the health plans. CAAs provide services that the managed care plans are not accustomed to delivering, and the plans have the member information CAAs and their role in community navigation, social determinants of health, community partnerships to develop ecosystems, etc. The new state RFP emphasized community partnerships and leveraging a new CMS allowable Medicaid funded In Lieu of Services (ILOS) option. This session will offer ideas in which CAAs can leverage these opportunities and in turn maintain a sustainable funding stream for services. Historically various challenges have discouraged Medicaid health plans and providers from assisting beneficiaries with nonmedical concerns such as housing insecurity or access to healthy foods, both of which that are integral to improving health outcomes and lowering costs. The work that the CAAs do as part of their business ties directly to the ILOS opportunity where Medicaid funding is now allowable for these services.

Early Childhood Career Pathway Program

The Early Childhood Career Pathway program is an initiative that was initially funded by the WK Kellogg Foundation in 2019. Community Action of South Central Michigan manages the program on behalf of all child care businesses in Battle Creek. The mission of the program is to recruit and retain individuals in the early childhood education profession by providing free training towards credentials and ECE degrees. The program has gone from 16 in first cohort to currently serving over 200 participants in the community. Over 100 individuals have received a CDA (Child Development Associate), many more have been assisted with renewals and as of January 2024, 5 participants have earned their associate degree in Early Childhood Education. The program's success rate is strengthened by monetary incentives, tech support, barrier assistance, and educational coaching/ mentoring. The road to building quality early care workers has resulted in several other ECE initiatives in Battle Creek. The presenters will tell you about creative ways to stretch funding, exciting initiatives, and successful recruiting techniques and incentives that have been effective in Battle Creek, to build a stronger early childhood workforce in the community.
